OPERATES ONE OF THE LARGEST CLIENT-CHOICE FOOD PANTRIES IN NORTH TEXAS, PROVIDING
ESSENTIAL FOOD, PERSONAL HYGIENE, AND HOUSEHOLD NEEDS TO MORE THAN 2,700 INDIVIDUALS
EVERY WEEK. THE CCA FOOD PANTRY HAS BEEN VOTED THE #1 FOOD PANTRY IN NORTH TEXAS FOR
THE LAST 7 YEARS. CCA'S CLIENT-CHOICE DISTRIBUTION MODEL EMPOWERS CLIENTS TO CHOOSE
